## OVERVIEW OF THE GOLF COURSE

Los Naranjos has the hallmark design of Robert Trent Jones Sr. with generous fairways and strategically placed bunkers and water hazards. The greens, with Penn A4 grass, are spacious and slightly undulated. The tees are long and have four markers: 50, 58, 61 and 65 with course lengths starting from 5.054 meters and reaching 6.564 at its longest.

Since the opening in 1977, Los Naranjos is ranked one of the best golf courses in Spain, and has been the host of several major competitions, including the Spanish Open. In 2005 and 2008, Los Naranjos was voted Course of the Year in Costa del Sol.


As a shareholder member of Los Naranjos GC, you are part of an international club with a beautiful, relaxed atmosphere, where friends are easily made and wonderful memories created.



## HOW TO BECOME A SHAREHOLDER MEMBER AT LOS NARANJOS

To become a member at Los Naranjos Golf Club, one must own a share in the company, Nueva Andalucia Holdings PLC.

Beginning 1st January 2026, shares may only be purchased through the Club from existing shareholders willing to sell. There are two types of shareholder membership at Los Naranjos:

**Family Share** (2 adult shareholders, with possibility to extend playing rights benefits to their school-aged children)

### Individual Share

The share ownership is a pre-requisite to enjoying the membership rights at the Club. A one-time inscription fee is paid at the Club for activation, and an annual fee is billed thereafter commencing the following year.



## THE APPLICATION PROCESS TO BECOME A SHAREHOLDER MEMBER

- Prospective new members will contact Los Naranjos Golf Club. The application process begins by emailing their intent to purchase a share to Ken Lingwood, Membership Relations Director at Los Naranjos Golf Club.
- Existing shareholder members willing to sell their shares will inform Los Naranjos Golf Club of their intent and the asking price for the share. The Club will assist both parties in facilitating this process under our internal rules and regulations in force from time to time. When an agreement has been made between the parties, the corresponding purchase between buyer and seller may be processed.
- Upon completion of payment to the former owner, the Club will require a scanned copy of the payment confirmation received by email, as well as full receipt of the transfer fee in order to process the stock transfer and issuance of the share certificate. Los Naranjos Administration Office will assist with the stock transfer.
- The new shareholder activates their membership playing rights with the Club upon confirmation of the inscription fee payment.



### *Important:*

*Please note that the information shared in this document are for guidance purposes only. Buyers and Sellers should use their own professional advisors for legal advice concerning the transaction. Nueva Andalucia Holdings PLC is the company which owns the golf course and its related facilities. You do not have to be physically present in Spain to buy or sell a share, you can set up an agent with your Power of Attorney, in original form, to carry out your part of the transfer.*

*Shareholding is transferable to your next of kin with a transfer fee equal to the annual fee at the time of transfer.*

## BECOME A PLAYING RIGHT MEMBER AT LOS NARANJOS

Email or visit us at Los Naranjos Golf Club for your application to be a Playing Right Member. You may begin your membership any day and this is valid for one full year.

Documents required with your application are a passport-sized photo, scanned copy of your passport or identity card, handicap certificate.

Upon approval of the Board of Directors of Los Naranjos Golf Club, an invoice for the Playing Right Membership will be issued to you by email.

Playing Rights for Family are not available, however with your individual playing right membership, you enjoy discounts on green fees for your guests.

Our Business Club members benefit from having brand visibility, presence and the opportunities to network with our elite community of members during tournaments and social events held throughout the year.

Your company's membership may begin any day, and this is valid for one full year. Benefits not used during the contract period may not be extended nor compensated in any form.

When a formal agreement is signed between Los Naranjos GC and your company, an invoice will be issued. Upon confirmation of the payment, we will request for a scanned copy of the passport of the company's official representative, who will be the primary contact for Los Naranjos GC. A high-resolution file of the company logo will be required for acknowledgment on our website.



## LOS NARANJOS GOLF CLUB PLAYER GUIDELINES

**DRESS CODE** Los Naranjos Golf Club follows world-class standards to ensure a professional, enjoyable and respectful environment for all players. We maintain a dress code that reflects the traditions and etiquette of the sport. Proper golf attire and closed shoes are mandatory. The following clothing are not permitted: T-shirts, polo shirts without sleeves or collar, beachwear, jeans.

**GOLF GAMES** Are made up of four-balls. The Club has the right to add up 1, 2 or 3 players to a flight in order to fill it to 4 players.

**USE OF BUGGIES** is only allowed for players over 18 years old, a maximum of two buggies (shared by 2 players) are allowed per flight.

**CANCELLATION OF RESERVATIONS** must be done at least 48 hours prior to the date and time of play. After this period, no cancellations or requests for refunds will be accepted.

**PACE OF PLAY** for a round of 18 holes is 4 hours and 15 minutes. Our Marshall may ask you to skip the hole if the flight is too slow.

**HANDICAP** certificate must be in possession by the players. Maximum handicap for gentlemen is 27 and 35 for the ladies.

**ONLY PROFESSIONALS** may be accompanied by caddies with prior request and authorization by the Club.

**PLAYERS UNDER 18 YEARS OLD** must be accompanied by an adult with prior request and authorization by the Club.

**ONLY AUTHORIZED PLAYERS ON THE GOLF COURSE** and restricted for companions. The Club has the right to ask visitors to leave the premises if Club rules are not respected.

**DOGS AND OTHER PETS** are not allowed for non-members. Only Members may bring their dogs in the Club premises, Restaurant and with a leash on the golf course.

**TWILIGHT TEE TIMES** do not guarantee finishing 18 holes due to the sunset.

**MAINTENANCE OF THE GOLF COURSE** is scheduled every 11th, 12th and 13th of May and the 24th and 25th of August.

**LOCKERS ARE AVAILABLE IN THE CHANGING ROOMS** for players and members to store their belongings. The Club will not be responsible for any lost or damage of belongings during the golf game on the course.

**UNPLAYABLE COURSE** If a player chooses not to play due to adverse weather conditions, there is an option to receive a voucher for a future round under identical conditions. This will remain valid for a maximum of six months from the date of issue and signed by the management. If players voluntarily start a round but are later forced to abandon it due to weather conditions, the following rules apply:

- If players have played less than 9 holes, they will be issued a voucher for 18 holes.
- If players have played 9 holes, they will be issued a voucher for 9 holes.
- If players have played 10 holes or more, no voucher will be issued, and any claims for compensation are forfeited.
